One specifically targets peers and educates them on the benefit of organizational involvement, while the other enlightens a political official on the impact FBLA has on the youth they represent.

How should I advocate?

- Showcase your local chapter on the community level and spread the message of Service, Education, and Progress that our organization offers.
- If you truly feel like taking the next step of Advocacy, feel free to contact an impactful official in your community to converse on the subject of FBLA.
- Offer to put together a presentation so others understand the opportunities members are given through FBLA.
- Remain as transparent as possible during these interactions as possible. Your sincere stories and support are more than enough to garner backing.

This year, changes have been made to the following ribbon projects: Sweepstakes, StepUp2Tech, and Connect to Business.

For the Sweepstakes Award, chapters must complete two of the four chapter reports. Reports must adhere to competition guidelines and follow the written rating sheet. The reports must score a 50% or higher of available points. Chapters are also encouraged to charter a middle level chapter, as well as have five members attend a business competition.

The expansions to the StepUp2Tech asks that members submit a 100-word summary documenting the implementation of technology in a business classroom by an FBLA member. It is encouraged to have at least one person in your chapter submit a t-shirt design for SLC that relates to this year's current theme.

The Connect with Business ribbon now has seven required activities, and two optional activities have been added to allow members more opportunities to network with local businesses. There are pending changes being made to the March of Dimes ribbon.

Another change this year is the due date. All ribbon projects are due by **February 28, 2020**. All submission forms and individual due dates can be found on the Nebraska FBLA website at https://nebraskafbla.org/ribbon-projects/. We look forward to watching all of you explore your World of Opportunity within the ribbon projects this year!

STARR'S REPERTOIRE: DRESS FOR SUCCESS

Flannel shirts, bolo ties, and open-toed shoes. What does this trio of misfits have in common?

The answer, quite simply, is none of them are approved FBLA apparel.

So, what is appropriate to wear to FBLA events?

At business professional events, men should wear a business suit with dress pants, a collared dress shirt and a neck or bow tie. A blazer may also be paired with dress pants, a collared shirt, and tie. Women may wear a business suit with either dress pants or a skirt with a blouse. A business dress with sleeves and an appropriate length is also suitable.

Now that you know what is acceptable to wear, we can look at what is unacceptable. At FBLA conferences, jewelry in visible body piercings other than your ears is not permitted. Shorts and hats are another breach of FBLA dress code. You should also steer away from skin-tight or revealing clothing such as tights, tank tops, and short skirts or dresses. (These are also great tips to keep in mind when interviewing for a job.)

No outfit would be complete without shoes. There are some shoes that should not be worn for FBLA, including flip flops or casual sandals (sorry, no Birkenstocks!), athletic shoes, hiking boots, Sperry's, and any canvas or fabric shoes. Men should sport dress shoes, and women should wear closed or peephole flats or heels.

Blazers, slacks, and closed-toed heels—what common ground does this triad possess? Well, there is only one answer to that. They are all appropriate to wear to business and FBLA events. Remember, there are acceptable and unacceptable clothes to wear to FBLA functions. Now, go dress like true Future Business Leaders of America.



In order to raise awareness, the Centura FBLA members participated in March of Dimes Week as well as a few fun festivities at a football game.



During this week facts about premature babies and March of Dimes were shared through the morning announcements. Posters with information were hung inside and outside the school to help inform the students, parents, and teachers of the March of Dimes organization. A fun activity that the Centura FBLA has facilitated for multiple years is the "Baby Guess Fundraiser." For this fundraiser the Seniors of Centura High were asked to share a baby picture of themselves with Centura FBLA treasurer, Rhegan Jensen. These pictures were then cut and pasted onto a poster and hung on a rolling cart. To finish things off, the cart was topped with slips of paper, pencils, and a donation jar. Each picture was assigned a number on the poster. Students came to guess who the babies were before, during, and after school. A 25 cent donation was required to participate in the activity. By the end of the week the donation jar was filled with change from generous donors, eager to guess the names of the babies. Another money maker for the Centura FBLA members was the "Teacher's Jeans Day." Teachers at Centura High made a \$5 donation to wear jeans to school. This in combination with the baby guess made a generous amount of money to donate to the March of Dimes foundation.

At the end of the week on September 20th at the home football game versus Hershey, Centura FBLA hosted their 2nd annual March of Dimes Walk during half time of the football game. Students who were dressed in purple clothing waited in line for glow gear before they took a lap around the track. Many of the participants visited the face painting station run by Centura FBLA to get their cheeks decorated. Donation jars were placed at the concession stands and at the face painting station in order to help raise money for the March of Dimes organization. During the actual lap around the track a March of Dimes banner was carried to draw attention towards the walk. Other things were done to help raise awareness as well. This includes banners and posters that were hung around the football field with facts about premature babies. The Vogt family of Boelus was present at the March of Dimes Walk as guests. Derek and Michelle Vogt are the happy parents of Declan who was born premature. At the March of Dimes Walk they shared their story for all of the fans to hear. Their story was played over the speakers while Michelle and Declan participated in the walk as well. Centura FBLA was happy with the turn out of the 2nd annual March of Dimes walk. The chapter hopes to have more successful walks and fundraisers to support the March of Dimes in their community!

Each meal cost less than a dollar to make and feed a family of six. Lakeview FBLA packaged enough meals to feed 6,900 people and gave a \$25 donation. Orphan Grain Train packages clothing, bikes, and medical equipment to send to those less fortunate. Along with the packages, Lakeview FBLA gave a \$25 donation.

Sandhills

The committee members met on Friday, October 25 to set up and decorate for the FBLA Halloween Party. New games were added and spooky guests were set up to welcome the party-goers.

The Halsey Elementary Gym was the place to be if you wanted to meet a unicorn, zombies, superheroes, Frankenstein, Dracula, witches, scarecrows, the Ghostbusters, and a T-Rex, just to name a few! On October 27, the Sandhills FBLA annual Halloween

The March of Dimes Walk raised \$517 from the registration and donations. The money raised went to the March of Dimes Foundation. Kelly Hauschild kicked off the event by sharing her experiences of having a premature baby.



The walk took the participants around the park twice.

The chapter raised \$1,767 from the Gold Out through a split-the-pot fundraiser, donations and gold t-shirt sales. The winners of the split-the-pot graciously donated the money back to the cause. The t-shirts were designed by FBLA members, Megan Wallman, Taylor Mead, and Kendall Meyer. Over 200 t-shirts were sold and worn to the games. Matching the crowd, the volleyball team wore gold shirts for warm-ups, and the softball team wore them as that game's jersey. The money raised was donated to the Pediatric Cancer Action Network. The organization's mission is to reduce the financial burden placed on families diagnosed with pediatric cancer and to advocate for a cure through awareness, education and action in and around Nebraska.



Twin River

Twin River FBLA hosted another elementary walk this year with the assistance of PE teacher Renae Van Driel. FBLA members went into elementary classrooms to share information with the students about how their donations would benefit the Genoa Long Term Care facilities. The money will be used to purchase a new air conditioning unit for residents use. Students were asked to go door to door to collect donations for the cause.

The walk to benefit the cause took place on October 15 and was a great success. The weather was beautiful and students had a great time walking along with collecting donations. FBLA members assisted Mrs. Van Driel with the walk. Many of the elementary students walked over two miles and some made it three. Prizes were awarded to students who raised certain amounts for the walk. Students who raised \$10 received a Pump and Pantry certificate for a free fountain pop. Students raising \$25 were awarded a candy bar and drink card. \$50 was a Gatorade, candy bar, and drink card and \$100 students received a t-shirt along with everything else for their excellent work. Over \$2,900 has been raised so far for the Genoa Long Term Care Facility.
